Sir,

It is within your knowledge that vide this office memo in reference it was requested to take up the various developmental works as mentioned below of the recognized non-Govt. aided Madrasahs under MGNREGS such as-

- Construction/renovation of Pathway leading to Madrasah from the main road/approach road;
- Earth-filling of the uneven playground/open spaces for use of the same in all weather;
- Construction of brick-paved approached road leading to and inner side of the Madrasahs;
- Leveling of field/space and plantation under Social Forestry etc., for beautification as well as creating healthy, hygienic and student-friendly atmosphere;
- Cleanliness within and inside the Madrasahs;

But, on review of the matter in the meeting dated 23.05.2014 in the Chamber of the Secretary, Minority Affairs and Madrasah Education Department, it is seen that in many cases works could not have been taken up under MGNREGS with the help of the Panchayet of various tiers of the Districts.

So, you are requested kindly to take up the matter totally and to instruct the respective Panchayets as well as the recognized non-Govt. aided Madrasahs to take up the works under MGNREGS for creation of more man-days under the scheme as well as for beautification, cleanliness of the educational institutions.
